

DEFINITION FOR MEMBERSHIP APPLICATION

The institute's membership is open to any person, organization or corporate body which has the same objectives and interest in achieving the objectives of the Institute.

The Members of the Institute shall consist of Ordinary, Life, Associate and Honorary Members as follows:

(a) **Ordinary Member**

- (i) Any person who is a Malaysian citizen of not less than 21 years of age, organization or corporate body duly registered in Malaysia and described under Article 4 and in the opinion of the Board is fit and proper to be an Ordinary Member and is involved, directly or indirectly in maritime related fields.
- (ii) Any Ordinary Member shall have voting rights and be eligible to hold office in the Board
- (iii) The entrance fee payable by an Ordinary Member shall be –
 - Individual – RM100.00
 - Corporate – RM1,000.00
- (iv) There shall be payable by an Ordinary Member, an annual subscription fee as follows:
 - Individual- RM50.00
 - Corporate- RM100.00

(b) **Life Member**

- (i) Any person who is a Malaysian citizen of not less than 21 years of age, organization or corporate body duly registered in Malaysia who qualifies as an Ordinary Member pursuant to Article 4A (a) (i)
- (ii) A life Member shall have the same privileges as an Ordinary Member
- (iii) The entrance fee payable by a Life Member shall be -
 - Individual- RM100.00
 - Corporate- RM1,000.00
- (iv) There shall be payable by a Life Member, a one-off lump-sum annual subscription fee as follows:
 - Individual- RM400.00
 - Corporate- RM3,000.00

(c) Associate Member

- (i) Any person, organization or corporate body who does not qualify to be an Ordinary Member pursuant to Article 4A (a) (i) but who in the opinion and discretion of the Board is beneficial to the Institute.
- (ii) An Associate Member shall be entitled to enjoy all the privileges of an Ordinary Member save that he shall not have any voting rights nor be eligible to hold any office in the Board.
- (iii) The entrance fee payable by an Associate member shall be

Individual- RM100.00

Corporate- RM1,000.00
- (iv) There shall be payable by an Associate Member, an annual subscription fee as follows:

Individual- RM50.00

Corporate- RM100.00

(d) Honorary Member

- (i) Any person whom the Board may invite to be an Honorary Member, by virtue of his public standing or expertise in maritime related fields, for such period of time and upon such terms and conditions as the Board may in its absolute discretion decide.
- (ii) An Honorary member shall be exempt from paying the entrance fee and the annual subscription fee but shall be entitled to enjoy all the privileges of an Ordinary Member save that he shall have no voting right and shall not be eligible to hold any office in the Board.
